



## **2020 OASC President and Vice President Election Checklist**

*The following items are the required components for a school to run for President or Vice President. Each component is described in detail on the following pages.*

- Completed application postmarked by midnight September 18, 2020.
- Information generally shared at the Campaign Booth promoting the school running for office will instead be shared out on the website via info submitted on a Campaign Booth google form Template provided by the OASC under the State Convention tab under election materials on oascok.org (template will include spaces to share written school qualifications, campaign/platform information as well as a slot for a 30 second maximum video) submitted by midnight, September 25, 2020.
- Submission of written campaign speech, emailed by midnight, September 18, 2020.
- Campaign speech posted before the State Convention - one minute minimum, and a four minute maximum youtube link (comments turned off) emailed by September 25th, 2020.



## OASC 2021 State Officer Application

To run for the OASC State President or OASC Vice-President you must return this application postmarked by **September 18,, 2020**. Please check the OASC Constitution for specific duties. If elected, the state officer is required to work both sessions of BASIC, attend one session of Advanced, attend the pre/post-trip and NatStuco convention, and attend board meetings (with his or her sponsor, if possible).

### Candidate School Speech Video

Each school will submit a link to a video uploaded to youtube to be posted on the OASC/State Convention website. There is a one-four minute maximum. **Please send a link to your youtube video with the comments turned off, not a video file.** Youtube video links to your speech must be emailed by midnight, September 25, 2020. All materials are to be sent to the 2<sup>nd</sup> year Advisor identified on the application.

### Video Rules and Content

- Campaign school must produce a video uploaded to youtube (with the comments turned off) of no more than one-four minutes in length, single shot of the candidate in front of a plain white background with no editing except the addition of the first and second nomination to the beginning of the video (no props ) that conveys the platform of the school running. This video should serve as a declaration of principles on which their school stands as they run for office.
  - *Note: Your school's only running announcement is your campaign booth apple page and submitted speech, which will be posted at oascok.org and state convention website on October 16th. Announcements of your candidacy in other forums is considered campaigning, and a violation of campaign rules. Only candidates listed on the OASC webpage are considered certified candidates.*
- Video cannot exceed four minutes and must be posted on youtube (with the comments off).
- The youtube video needs to be named as follows: Candidate school name – OASC Office. For example, **Bayside High School - OASC President Candidate**
- If filmed on a phone, the video must be in landscape (horizontal) orientation.
- The only person to appear in the video is the student that would represent the school as the state officer.
- The video is one shot, one angle, no editing with the exception of adding your first and second nominations to the beginning.
- The backdrop is to be one color, white – nothing else.
- The candidate should introduce the school and themselves.
- The candidate should quickly touch on reasons the school is running for state office.
- The candidate is not to discuss individual accomplishments. **Please remember, the school is running for office, not the individual.**



- The theme of your booth can be tied into this video.
- Dress should be professional.

**Rules for State Candidate Campaigning**  
(Updated July 2020)

- **Campaigning may not occur prior to posting campaign booth info on the website and campaign speech on oascok.org and convention site on October 16th, 2020. This would include but is not limited to mail, email, social media, text messaging, videos, letters, and or flyers.**
- *There is not to be any campaigning in the general sessions (no campaign signage during zooms and/or campaigning in the chat boxes).*
- Campaigning by a candidate or by anyone acting on his/her behalf will begin at the posting of the campaign booth.
- The final part of the campaign is before the start of the first general session as voting takes part the conclusion of the first general session..
- Campaigns and speech should focus on promoting the qualifications of the school, NOT THE INDIVIDUAL.
- Campaign and speech should include / feature highlights of leadership programs and OASC involvement of the school, not the individual.
- Campaign and speech could include ideas for the OASC that the officer would like to implement during their tenure.
- A drawing will take place at the host school to determine the order in which schools videos will be placed on the website.
- **GIVEAWAYS AND/OR HANDOUTS ARE NOT ALLOWED (including but not limited to giving other schools candidate school shirts). Result of Giveaways/handouts by a candidate school is loss of both voting delegates for business session and voting of President and Vice President. This giveaway rule includes before and during the convention.**

### Campaign Booth

- Schools will be provided a Campaign Booth google form template (google form posted to [oascok.org](http://oascok.org) under State Convention tab and under election materials for schools to fill out) in lieu of a physical campaign booth this year. Schools are required to upload a video and submit information regarding school platform and school qualifications and stay within the set character limit on the google form.
- Again, **GIVEAWAYS AND/OR HANDOUTS ARE NOT ALLOWED.**
- The booth can have a theme, but the booth must reflect why the school is a good candidate for the office for which they are running.
- No signage outside this campaign zone are permitted.

Directions for template:

Three main things to include when submitting your Campaign Booth google form template:

- 1) An interactive video of how your school would approach a delegate at your campaign booth to get their support. Please limit your video to 30 seconds. Please remember to film in landscape angle not portrait mode. You can be as creative as you want here, but only students in your school can be in your video.
- 2) Information about your school's platform.
- 3) Information about your school's qualifications.

Submit the Campaign Booth google form by midnight on September 25th.



### Speech Information (Updated June 2020)

1. Plain white background/lighting will be used.
2. Total time for presentation is 4:00 minutes—This includes: Nominations (1<sup>st</sup> & 2<sup>nd</sup>), and Speech.  
**The speech should be professional in nature. It must be presented by the candidate(s) who will represent the school and must be a minimum of one minute in length of the four minutes. The speech should address why the school is the best candidate, not the individual. The campaign booth theme can be incorporated into the speech.**
3. Your time begins when the video starts (the first nomination). Remember that you must have one school nominate you, and one school to second that nomination. First and Second Nominations will have to be shot on video and sent to your school to add to your final speech which will be uploaded to youtube (with comments disabled).
4. No props will be allowed during the speech
5. Dress is professional or a campaign t-shirt with black or khaki pants. No costumes!
6. Only regular lighting allowed.
7. If your speech runs over the 4 minutes allowed, the Second Year Advisor will return your youtube link with instructions to reshoot your video to meet time limitations. **In addition, the school will lose one voting delegate for business session and voting of president and vice president at state convention.**

### Voting and Election Procedures

- According to ARTICLE V, Section 5 of the OASC Constitution, *Election shall be majority of the official voting delegates present. To win on the first ballot, your school must receive 50% plus one more vote cast in your race. Runoffs will be between the two schools with the highest number of votes. In the runoff the one with the most votes wins. No school may have more than two votes and no voting by proxy.*
